RESOLUTION # 2852: A RESOLUTION TO LEVY AND ADD TO THE TAX ROLLS THE FIRE DEPARTMENT MILLAGE RATES ON PROPERTY WITHIN THE CITY SUBJECT TO AD VALOREM TAXATION FOR THE YEAR 2016 AS APPROVED BY THE VOTERS OF THE CITY OF GONZALES ON MARCH 28, 2015.

The following Resolution was offered by Councilman, and seconded by Councilman Neal Bourque, and seconded by Councilman Kirk Boudreaux:

NOW, THEREFORE, BE IT RESOLVED, that the City of Gonzales, Parish of Ascension, Louisiana, in a Public Meeting held on October 10, 2016, conducted in accordance with the open meetings law and the additional requirements of La. RS 42:19.1, that the following millage rate is hereby levied on the 2016 tax roll on all property subject to taxation by the City of Gonzales.

Millage:

BE IT FURTHER RESOLVED, that the Assessor of the Parish of Ascension, State of Louisiana, be hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2016, and to make the collection of the taxes for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.


