AN ORDINANCE AMENDING THE CODE OF ORDINANCE CHAPTER 20. UTILITIES. ARTICLE IV. – SEWAGE. SECTION 20-84. – SERVICE RATES. (CHANGE) (1) ALL BUILDINGS BILLED FOR WATER USAGE. (TO READ)

BE IT ORDAINED, by the Mayor and Councilman of the City of Gonzales, Louisiana:

That the Code of Ordinance of the City of Gonzales be amended as follows:

(CHANGE)

20-84. - Service rates.

(1) All buildings billed for water usage.

(TO READ)

(1) All buildings billed for water usage. All residential buildings billed for water usage, shall pay a minim sewer charge of fifteen dollars and thirty cents (\$15.30), to increase five percent (5%) each year for the next five years, and thereafter pay a sewer use charge of four dollars (\$4.00) per thousand (1,000) gallons for each one thousand (1,000) gallons of water used. All buildings, including, but not limited to commercial establishments, small office buildings, churches, schools, industries and auditoriums shall pay a minimum sewer charge of thirty dollars (\$30.00), and thereafter pay a sewer use charge of four dollars (\$4.00) per thousand (1,000) gallons for each one thousand (1,000) gallons of water used.
