Final vote on Ordinance # 4165:

AN ORDINANCE AMENDING THE CODE OF ORDINANCE, CHAPTER 22. ZONING, SEC. 22-2 ZONING DISTRICTS. TO APPROVE THE REQUEST OF BEARING POINT PROPERTIES FOR SAWGRASS VILLAGE TO REZONE LOT b-c1a-c2A, PARCEL #2573080, BEING APPROXIMATELY 15.91 ACRES, FROM C-1 TO PUD (PLANNED UNIT DEVELOPMENT), LOCATED AT THE SOUTHWESTERN INTERSECTION OF ORICE ROTH ROAD AND VETERANS BLVD.

BE IT ORDAINED, by the Mayor and Councilman of the City of Gonzales, Louisiana:

That the Code of Ordinance of the City of Gonzales be amended as follows:

Chapter 22. ZONING

Sec 22-2. Zoning districts.

Lot B-C1A-C2A, parcel #2573080, being approximately 15.91 acres, from C-1 to PUD (Planned Unit Development), located at the southwestern intersection of Orice Roth Road and Veterans Blvd.




