Final Vote on Ordinance No. 4191:

AN ORDINANCE AMENDING THE CODE OF ORDINANCE, CHAPTER 22. ZONING, SEC. 22-2 ZONING DISTRICTS. TO APPROVE THE REQUEST OF BEN FIELDS TO REZONE THE EASTERN PORTIONS OF LOTS A1B1A2 AND A1A1A, ADDRESSED AS 210, 211 AND 212 E. INDUSTRY, BEING APPROXIMATELY 2 ACRES, FROM C-MS (MAIN STREET) TO C-2 (COMMERCIAL).

BE IT ORDAINED, by the Mayor and Councilmen of the City of Gonzales, Louisiana:

That the Code of Ordinance of the City of Gonzales be amended as follows:

Chapter 22. ZONING

Sec. 22-2. Zoning Districts.

The eastern portions of Lots A1B1A2 and A1A1A, as indicated on the attached map, addressed as 210, 211, and 212 E. Industry, being approximately 2 acres, from C-MS (Main Street) to C-2 (Commercial).


