Final Vote on Ordinance No. 4192:

AN ORDINANCE AMENDING THE BOUNDARIES OF THE "NORTHEAST GONZALES ECONOMIC DEVELOPMENT DISTRICT".

BE IT ORDAINED, by the Mayor and Councilmen of the City of Gonzales, Louisiana:

That the Code of Ordinance of the City of Gonzales be amended as follows:

SECTION 1. Creation of District. On October 22, 2012, an economic development district was created within the City, to be named the "Northeast Gonzales Economic Development District," and the District boundaries were amended in March 2020, having the geographical boundaries set forth in Exhibit A and Exhibit B attached hereto.

SECTION 2. Amendment of Boundaries. The governing body of the district, being the Mayor and City Council, hereby elect to amend the boundaries of the district to have the geographical boundaries as set forth in Exhibit C and Exhibit D, which is hereby incorporated in and made a part of this Ordinance.

SECTION 3. Authorization of Officers. The Mayor, Mayor *pro tem* and City Clerk are hereby authorized, empowered and directed to do any and all things necessary and incidental to carry out the provisions of this ordinance.

SECTION 4. Severability. If any provision of this ordinance shall be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this ordinance, but this ordinance shall be construed and enforced as if such illegal or invalid provisions had not been contained herein. Any constitutional or statutory provision enacted after the date of this ordinance which validates or makes legal any provision of this ordinance which would not otherwise be valid or legal, shall be deemed to apply to this ordinance.

SECTION 5. Repealer. All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 6. Publication; Effective Date. This ordinance shall be published one time in the official journal of the City and shall become effective immediately.




