ORDINANCE # 4195

AN ORDINANCE AMENDING THE CODE OF ORDINANCE, CHAPTER 22. ZONING, SEC. 22-2 ZONING DISTRICTS. TO APPROVE THE REQUEST OF SCOTT PETRIE TO REZONE TRACT A-1-C-2-A, ADDRESSED AS 625 W. ORICE ROTH ROAD, BEING APPROXIMATELY 5.179 ACRES, FROM R-8 (SINGLE FAMILY RESIDENTIAL) TO C-2 (COMMERCIAL).

BE IT ORDAINED, by the Mayor and Councilman of the City of Gonzales, Louisiana:

That the Code of Ordinance of the City of Gonzales be amended as follows:

**Chapter 22. Zoning districts.**

Rezone the Tract A-1-C-2-A, as indicated on the attached map, addressed as 625 W. Orice Roth Road, being approximately 5.179 acres, from R-8 (Single Family Residential) to C-2 (Commercial).


