Chapter 11. GARBAGE, TRASH, WEEDS AND WASTES

Article III. - WEEDS AND GRASS.

(CHANGE) SECTION 11-58. - Maximum height allowed.

(TO ADD)

(c) Exception to (b), if a pasture or field containing livestock is adjacent to a residence, then the maximum height allowed is twelve (12) inches. A hay bailing permit would be allowed in that circumstance.
