Terrace Street. Furthermore, a stipulation that was agreed upon during the December 12, 2022 Council Meeting, to give Ms. Williams more time to choose a contractor and get the repairs underway, was that she present the Council with a signed contract at this meeting (1/9/23). Ms. Williams did not bring a copy of the signed contract with TBC Contractors.

Motion by Councilman Tim Riley, seconded by Councilman Kirk Boudreaux, allowing four-five days for Ms. Williams' contractor, TBC Contractors, to get licensed with the City and to secure the proper permits to do the repair work at 432 W. Terrace Street, in addition to Ms. Williams bringing a copy of the signed contract to City Hall. In the event these conditions are not met by the next Council Meeting on January 23, 2023, Ms. Williams must appear before the Council at that time.

F. Non combustible, non-permanent structures, such as metal sheds and RV covers.

If the lessee does not notify the lessor of a cancellation with a period of ninety (90) days of the scheduled event, said deposit will be forfeited unless cancellation is caused by an act of God or other natural disaster. Deposit will also be forfeited if there is an event which requires officers to intervene at the event to maintain the peace.
