Kyle Zimmerman, 410 N. Bryan Ave., Gonzales, came forward to speak in opposition to the Special Use Permit. He feels it doesn't belong in a residential neighborhood and worries that it may decrease the property values. He stated that the rights of the property owners should supersede the small minority that want The Haven at this location.

Karen Zimmerman, 410 N. Bryan Ave., Gonzales, came forward to speak in opposition to the Special Use Permit. She stated that she runs a sober living home in a commercial zone and The Haven's proposal to have one resident manager and one paid outside manager is not good management. She is also concerned it will make the property values decrease.

John McClure, 410 E. Weber, Gonzales, came forward to speak in opposition to the Special Use Permit. He stated his property backs up to the proposed site for The Haven. He stated he has no issues with the goal of The Haven, but there are better areas to put it in, rather than a residential area.

Lonnie Landry, 408 E. Sanders, Gonzales, came forward to speak in opposition to the Special Use Permit. He stated his property is directly across from the proposed site for The Haven. He requested that the Council vote no.

Suzanne Williams, 408 E. Sanders St., Gonzales, came forward to speak in opposition to the Special use Permit. She stated that her property is directly across from the proposed site for The Haven and feels it will be a place with a revolving door for short-term residents. Ms. Williams also submitted into record a petition signed by herself and other community members.
