ORDINANCE # 4249

AN ORDINANCE AMENDING THE CODE OF ORDINANCE, CHAPTER 18 TAXATION. 18-37. Itinerant Vendors Prohibited (AMEND):

BE IT ORDAINED, by the Mayor and Councilman of the City of Gonzales, Louisiana:

That the Code of Ordinance of the City of Gonzales be amended as follows:

Chapter 18-37 . Itinerant Vendors Prohibited

(AMEND)

It shall be unlawful for any itinerant vendor to sell, offer to sell, exhibit for sale, or exhibit for the purchase of taking orders for the sale thereof any goods or merchandise in the City of Gonzales.

(TO READ)

It shall be unlawful for any itinerant vendor to sell, offer to sell, exhibit for sale, or exhibit for the purchase of taking orders for the sale thereof any goods or merchandise in the City of Gonzales except those mobile food retailers licensed by the City and who possess a permit approved by the City Council for special occasions or public purposes and subject to applicable City rules and regulations.


